- 2 Print your full name, date of birth and licence number on the back of the photo.
- 3 Take this form and the passport photo to be witnessed. A description of persons who can be witnesses is on the right.
- 4 The witness must:
 - · read this form
 - · see your evidence of identity
 - complete the witness details below
 - sign this form and the back of the photo.

Authorised witnesses

An authorised witness includes any of the following people:

- an employee of VicRoads
- an accredited licence assessment provider or agent
- a member of the police force
- a consular or ambassadorial officer
- a person authorised to witness and sign statutory declarations
- a person having one of the above equivalent occupations in another state or country.
